\*Only trailers for boats stored at the Club (wet or dry) can be considered. The members name must be clearly marked on the trailer. Unidentified trailers may be removed from the dingy park and sold or scrapped with no further notice.

**BYELAWS OF PARTICULAR NOTE**

- The Hon. Harbourmaster reserves the right to change moorings and to move boats as necessary.
- The Club may dispose of boats for which mooring fees are more than three months in arrears.
- Boats must be properly looked after and used reasonably or the Harbourmaster may demand their removal.
- Owners are responsible for maintaining their allocated mooring.
- Particular attention must be paid to maintaining a mooring bridle at its correct length, which is the same as the mooring length.
- All cruisers, dinghies and trailers must be clearly marked with their identity. Trailers must be marked with owners name.

- I understand that this application is for one year only effective from 1st March 2020 and accept the allocation of a mooring or boat/trailer space is at discretion of the Harbourmaster and does not provide any ongoing or assignable right to any particular mooring space.
- I agree that Twickenham Yacht Club may hold my email and telephone numbers solely for the purposes of contacting me in matters relating to mooring my boat and associated activities.
